Acts ch. 175, Part II, A., 10., 005.) and authorizes new Bond Funds in the amount of \$36,240,000 for a total of \$40,000,000 in Bond Funds for SFCC's regular offers of assistance. These offers of assistance are made to individual school districts based on a district's unmet facility needs relative to the unmet need statewide (KRS 157.622). House Bill 6 from the 2024 Regular Session of the General Assembly authorized the School Facilities Construction Commission to make offers of assistance in the amount of \$40,000,000 with the expectation of debt service in the 2026-2028 biennium. To assist local school districts, this authorization will allow the Commission to participate in the financing of major renovation or construction projects contained in each local school district's prioritized facility plan.

Funding for this project is contingent upon approval for the use of Restricted funds from the Aviation Economic Development Fund. The project will construct a new airport terminal building (approximately 8,000 sf) to replace the old and outdated terminal building at the Capital City Airport.			
Construct Sixteen New T-Hangars Reauthorization			
This project reauthorizes \$2,750,000 in Restricted Funds. Funding for this project is contingent upon approval for the use of Restricted funds from the Aviation Economic Development Fund. This project will construct 16 new T-Hangars to provide secure storage space for civil aviation aircraft. Currently, there is a waiting list of 25 individuals who have expressed an interest in renting T-Hangars to store their personal aircraft. The additional T-Hangars will provide more secure aircraft storage and help generate additional revenue for Kentucky's Capital City Airport.			
Construct One Aircraft Maintenance Hangar Reauthorization			
This project reauthorizes \$6,9100,000 in Restricted Funds. Funding for this project is contingent upon approval for the use of Restricted funds from the Aviation Economic Development Fund. This project is to construct one Aircraft Maintenance Hangar to be used to maintain the State's fleet of aircraft. This hangar will include offices and restroom facilities. This will replace the existing 4,200 sq. ft. maintenance hangar that was built in the late 1950s that is structurally deficient and is inadequate for maintaining the state fleet.			
Construct Two Medium Sized Box Hangars Reauthorization			
This project reauthorizes \$1,600,000 in Restricted Funds. Funding for this project is contingent upon approval for the use of Restricted funds from the Aviation Economic Development Fund. Funds will be used to construct two new box hangars approximately 60' x 60'/3,600 square feet. These hangars will be available to corporate/private entities that require aircraft storage and operational space. This new construction will generate additional revenue for the operations of the airport and potentially attract new businesses to the area. The airport is growing and existing conventional hangar space is inadequate for current and future business operations.
